- VI. Recognition of Employees Jennifer Tunstall, Executive Director, recognized Deatrice Delk, Emergency Services Therapist/Hospital Liaison, as Employee of the Month for March 2019. When the Emergency Services Manager retired, Deatrice was appointed Interim ES Manager. She worked with Commonwealth Center attending the children's hearings, participating in treatment team meetings, and handled the discharge and placements, along with the massive role as ES Manager. She provided supervision and guidance to the ES program until the ES Manager position was filled. Deatrice is an asset to the agency and has been instrumental in supporting a crisis program that responds promptly to and works alongside the community. District 19 is proud to announce Deatrice Delk as Employee of the Month for March 2019. This award recognizes the exceptional and significant achievements of individual staff that exemplify District 19's excellence in public service.
- VII. Educational Topic: Diana Barnes, Manager of Specialized Children's Services, presented an overview of School Based Therapy. District 19's School Based Therapy program is intended to be creative, flexible and tailored to meet the needs of students in the school setting. The goal is to provide intervention and support to students to help them remain in the least restrictive educational placement. District 19 currently has three full-time School Based Therapists and one part-time School Based Therapist who provide mental health, substance use counseling and behavioral modification to students experiencing a wide range of academic, emotional and behavioral difficulties in a confidential setting. Crisis Intervention support is also provided when possible. We also provide trainings for staff upon request.

School Based Therapy is provided during the regular school day approximately one day per week. An individual or group counseling session will typically last 30-60 minutes to provide minimal disruption to the student's academic schedule. School Based Therapy is supported by small pots of money and general funds. Students are not charged for this service.

Revision to HR Policy 4.1.2 – Promotion – Mrs. Tunstall reviewed revisions to Policy 4.1.2 with the Board. The policy needed to be revised based on Salary Action within the policy. Currently, salary action is based on the number of grades promoted. However, based on the budget, program needs, experience of the candidate, and compensation of comparable positions, salary negotiations will be taken into consideration to determine salary increase. The increase percentages will not be automatic. The negotiated salary must be at least 5% above the employee's current rate of pay. In the event of a two grade or more movement, the new salary must be at least 10% higher than the current salary. If an employee's salary is still below minimum of the new salary grade, the employee's compensation is raised to the minimum level of the new pay grade.
