Mrs. Tunstall welcomed Col. Anthony Johnson to the meeting. He is our new Board member representing Greensville County. Col. Johnson will have a more formal introduction at our next meeting.

V. New Business

Legal Services – The Board of Directors was made aware that Mrs. Tunstall would be seeking new legal counsel as our current counsel would be terminating their services on January 31, 2022. Approval was given to Mrs. Tunstall to move forward in putting out an RFQ to select a firm to represent District 19.

Mrs. Tunstall and the Director of Operations, Melissa DeVault, interviewed Attorney Lauren Fisher White, who will represent District 19 in connection with employment and other legal matters as they arise, on an as-needed basis if approved by the Board. We were very impressed with her responses and knowledge specific to employment law. She also represents other Community Services Boards, so she is familiar with how we operate. A packet from the law firm of Christian & Barton was presented to the Board for review. Each attorney was listed with their area of expertise.

The Board inquired about the cost of services for new legal counsel, if it is a higher rate than the current firm, and if the cost had been added to the budget. Mrs. Tunstall explained that the hourly rate was higher, but was comparable to 3.8 hours per month that we pay with the current firm. If we use their services over four hours per month it will be a higher cost than we currently pay. However, with the expertise this firm brings, it may save us money due to efficiencies where they have a lot of experience.

It is not necessary to sign a contract as the Letter of Agreement presented to the Board fully outlines the responsibilities of the firm. They will submit itemized billing to show what we are spending for their services. If we ever want to terminate and seek other representation, we simply need to provide them with notice.
